Statement by Cyprus

"The Republic of Cyprus objects to the adoption of draft Council Implementing Decision Implementing Decision 2012/642/CFSP and the Draft Implementing Regulation implementing article 8(a)(1) of Regulation (EC) No 765/2006 concerning restrictive measures in respect of Belarus.

While political consensus has been reached on the speedy adoption of sanctions against Belarus and Turkey in parallel during the Berlin Gymnich, no progress has been achieved on the latter. Cyprus remains firmly committed to honouring the above political agreement in its entirety.

Cyprus objects to the way that the Presidency has chosen to proceed on this highly sensitive and complex matter. While it is the prerogative of the Presidency to launch such written consultations under the extraordinary COVID-19 situation, it is also disconcerting that, by choosing to launch a written consultation, the established practice of achieving political consensus amongst all Member States has been overlooked.

The choice to proceed in this manner while seeking to adopt restrictive measures, does set a very dangerous precedent, which can negatively impact EU sanctions' policy and endanger EU unity."

Statement by Portugal and Spain

"The amendment regarding fishing opportunities for anchovy, as set out in document 9800/20, sets the TAC for this stock in ICES subareas 9 and 10 and in Union waters of CECAF 34.1.1 for the period starting on 1 July 2020 until 30 June 2021.

Portugal and Spain understand the rationale of the proposal of the Commission, which is in line with the latest ICES advice, issued on 18 June 2020.

However, Portugal and Spain consider that the ICES approach should have taken into account the specificities of the western component of anchovy stock, in order to truly reflect the abundance of the biomass. We further underline that, according to the ICES advice, the interim approach used to analyse the stock is only preliminary and needs further development.

Portugal and Spain therefore regret that the anchovy fishing opportunities, one of the most important stocks for the Portuguese and Spanish small pelagic fleets, are based on an assessment that is not robust enough, which entails setting the TAC below its real and sustainable figure.

Since this stock has just a provisional TAC established until 30 September 2020 and that it is essential to ensure that fishery activities continue, Portugal and Spain are willing to support the document as it stands."

Statement by the Commission

"The Commission takes note of the fact that the political agreement relative to the Commission proposal on a framework for the recovery and resolution of central counterparties 2016/0365 (COD) has included provisions relative to open access requirements under articles 35 and 36 of the Market in Financial Instrument Regulation (MiFIR). These provisions were not included in the initial proposal of the Commission.

In the Commission's view, these provisions are not entirely in line with the EU's institutional set-up, in particular the Commission's right of initiative, and cannot constitute a precedent for future negotiations.

As the MiFIR changes at issue do not entail a substantive change of policy, but are rather limited to a short postponement of the MiFIR access provisions, the Commission will not now stand in the way of their adoption. This is without prejudice to any policy that the Commission may propose on this issue in the future."

Statement by Italy

Pertanto, nell'assicurare voto favorevole, l'Italia desidera sottolineare che l'applicazione dell'atto dovrà mirare ad evitare possibili effetti negativi e conseguire effettivamente l'obiettivo di facilitare gli Stati Membri che, come l'Italia, sono stati particolarmente colpiti dalla grave emergenza sanitaria in atto."

"Italy welcomes the Commission's proposal amending art. 50.1 of Regulation No. 514/2014 which is aimed at addressing the consequences of the Covid-19 pandemic on the management of funds for migration, security and border management, providing for further flexibility.

Nevertheless, Italy believes that this proposal may cause unintended effects, not adequately explored, on the spending targets, in particular for Member States, such as Italy, which received additional emergency funds.

Therefore, while voting in favor of the proposal, the Italy wishes to underscore that the implementation of the act should avoid possible negative effects and achieve the objective of assisting Member States, such as Italy, which have been particularly affected by the current health emergency."
