	Appointment of Ms Zuzana BRIXOVÁ, member for Slovakia, in place of Ms Ol'ga PIETRUCHOVÁ, who has resigned

- 1. The General Secretariat of the Council has been informed of the resignation of Ms Ol'ga PIETRUCHOVÁ as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Slovakia).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality², and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 27 May 2019³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2022.
- (2) A member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Ol'ga PIETRUCHOVÁ.
- (3) The Government of Slovakia has submitted a nomination for the vacant seat,
