The transfer request concerns the reinforcement of the Instrument contributing to Stability and Peace (IcSP) crisis response pillar in order to ensure adequate EU reaction to current and arising crises.

The Commission proposes the re-allocation of EUR 15 million from the budget line 19 04 01 - improving the reliability of electoral processes, in particular by means of election observation missions - under the European Instrument for Democracy and Human Rights (EIDHR) to the Instrument contributing to Stability and Peace (IcSP) budget line 19 02 01 to respond to ongoing crises in conflict-affected regions across the world.

d) Detailed grounds for the decrease

Due to the COVID-19 crisis, many missions were cancelled, delayed and changed, leaving a surplus of EUR 19,5 million in commitment appropriations on the budget line for Election Observation Missions under EIDHR:

- Elections were postponed (e.g. Ethiopia, Haiti);
- Election observation missions were cancelled and or replaced by desk review or election expert missions (e.g. Myanmar, Cote d'Ivoire, Dominican Republic, Bolivia, Sri Lanka);
- Election follow-up missions were cancelled (e.g. Kosovo, Sierra Leone, Zimbabwe, Liberia, Madagascar, and Lebanon).

The Commission therefore proposes EUR 15 million to be transferred to the Instrument contributing to Stability and Peace (IcSP) to support to ongoing crises. Another EUR 4,5 million are available to cover other purposes.

d) Detailed grounds for the increase

In 2020, 20% of the IcSP budget allocated to this budget line was spent on unexpected Covid-19 related actions specifically focussing on disinformation and conflict-affected communities. Combined with the fact that 2020 is the last year of the current Multiannual Financial Framework, this has depleted the ability to provide the rapid response actions for conflict prevention, mediation and crisis response that the IcSP is called upon to provide.

The developments in Ukraine, Syria, Libya, Somalia, and the Central African Republic continue to generate important needs, while new or rapidly evolving crises in Sudan, Nicaragua and Côte d'Ivoire require new timely engagements. In addition, previous engagements on on-going peace processes and reform efforts are being consolidated, and targeted initiatives were launched to prevent conflicts from escalation.

The reinforcement of EUR 15 million will be used for the following actions:

• to support the implementation of the ceasefire in Libya through additional demining, mediation and ceasefire monitoring measures (EUR 7,4 million);

- to cover needs in Latin America for additional support to health and conflict prevention measures in areas where many Venezuelan refugees are present (EUR 1,6 million); and
- to provide urgent support in Mozambique, where, for the first time, the government acknowledges that it requires EU help to address instability in the Cabo Delgado region (EUR 5 million).
- Discussions are ongoing on support to Belarus (strengthening independent media/civil society), Sudan and Mali (support to transition), which will require a reinforcement of EUR 1 million.
