**Committee of the Regions (CoR); Nomination of Landesrat Heinrich Dorner
as member of the CoR**

Pursuant to Article 305 TFEU, the Council appoints members and alternate members of the CoR for five years on the basis of a proposal made by each Member State. Where the term of office of a member or an alternate member is terminated before expiry of that period, a replacement is appointed for the remaining term of office by the same procedure.

Landesrat a.D. Christian Illedits announced that he would resign from his post as member of the CoR with effect from 3 August 2020.

On 7 October 2020, the Austrian Federal Government therefore decided to nominate Landesrat Heinrich Dorner to succeed Landesrat a.D. Christian Illedits.

Please find enclosed the details of the nominee in the form requested by the General Secretariat of the Council.

I would kindly request that you draw up the appointment decision for the earliest possible Council meeting.
