*Preparation for a general approach*

The SCA discussed the Presidency drafting suggestions on the CAP Strategic Plans Regulation set out in document 11508/20 + ADD1.

The Presidency took note of the comments from delegations and the Commission and would prepare a revised version with a view to reaching a General Approach at the October Council.

The SCA took note of the text of the Horizontal Regulation resulting from the deliberations in the Working Party AGRIFIN. The Presidency took note of the comments made by delegations and the Commission and would now prepare for the approval of a General Approach on the text at the October Council.

The Presidency noted divergent views on the inclusion of a threshold for financial discipline in Article 15 of the Horizontal Regulation. This issue would be further discussed at the October Council.

On the CMO, delegations considered the Amending Regulation broadly stable and agreed to forward the compromise package annexed to document 11241/20 to the Council with a view to reaching a General Approach.

### 6. Organisation of future work

The Presidency informed the SCA about the "Agriculture and Fisheries" Council meeting to be held in Luxembourg on 19-20 October 2020.

The Spanish delegation expressed their intention to table an AOB item, at that Council meeting, on the situation in the beef and veal markets.
