Subject: Draft Regulation of the European Parliament and the Council amending Regulation (EC) No 1393/2007 of the European Parliament and of the Council on the service in the Member States of judicial and extrajudicial documents in civil or commercial matters (service of documents) **(first reading)**
- Decision to use the written procedure for the adoption of the Council's position at first reading and of the statement of the Council's reasons

1. On 31 May 2018 the Commission sent its proposal¹, based on Article 81 TFEU^{2 3}, to the Council.
2. The European Economic and Social Committee delivered its opinion on 17 October 2018⁴.
3. The Committee of the Regions was consulted and decided not to issue an opinion.
4. The European Parliament adopted its position at first reading on 13 February 2019⁵.

5. On 22 July 2020, the Permanent Representatives Committee confirmed a political agreement on the Council's position at first reading on the above draft Regulation⁶.
6. Due to the special circumstances, the Permanent Representatives Committee is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision (EU) 2020/1253⁷, that the Council uses the written procedure for the adoption of its position at first reading on the draft Regulation of the European Parliament and the Council amending Regulation (EC) No 1393/2007 of the European Parliament and of the Council on the service in the Member States of judicial and extrajudicial documents in civil or commercial matters (service of documents), as set out in document 9890/20 and the Statement of reasons, as set out in document 9890/20 ADD 1.
