#### TRANSFER OF APPROPRIATIONS N° DEC 25/2020

#### INTRODUCTION

The present transfer proposes to move to the operational lines the appropriations available on the administrative lines, mainly due to the Covid-19 pandemic and related containment measures, for programmes under Heading 1.a (Horizon 2020, EGNOS and Galileo, Competitiveness of Enterprises and Small and Medium-sized Enterprises, International Thermonuclear Experimental Reactor and Copernicus), Heading 2 (European Maritime and Fisheries Fund and LIFE+) and Heading 3 (Citizens, Consumers and European Support Instrument) for a total value of EUR 14,3 million in commitment appropriations and EUR 14 million in payment appropriations.

# **Justifications**

# Decreased 02 01 04 01

#### Support expenditure for Competitiveness of enterprises and small and medium-sized enterprises (COSME)

Due to the Covid-19 crisis, several large events, workshops and conferences linked to the actions of the COSME programme were cancelled and an amount of EUR 0,6 million can be transferred to the operational lines of the programme.

#### Decreased 02 01 04 03

#### Support expenditure for European satellite navigation programmes

Due to exceptional circumstances linked to the Covid-19 situation, many of the communication activities were cancelled or postponed. An amount of EUR 1,8 million can be made available for the operational budget line. Technical assistance for Global navigation Satellite System will be financed with the appropriations remaining on the line.

# Decreased 02 01 04 04

#### Support expenditure for European Earth observation programme (Copernicus)

Due to exceptional circumstances linked to the Covid-19 situation, many of the communication activities were cancelled or postponed. Therefore, an amount of EUR 0,4 million can be made available.

# Decreased 02 01 05 03

#### Other management expenditure for research and innovation programmes -- Horizon 2020

The surplus on the administrative support line is due to the Covid-19 crisis and resulting lockdown, causing a significant reduction of missions and of the reimbursement for expert meetings.

#### Decreased 02 01 06 01

# Executive Agency for Small and Medium-sized Enterprises -- Contribution from Competitiveness of enterprises and small and medium-sized enterprises (COSME)

Taking into account the impact of the Covid-19 crisis and the containment measures on the administrative expenditure, an amount of EUR 0,5 million in commitment and payment appropriations can be made available. Besides, following the change in the percentage for salary indexation as compared to the Budgetary Circular, an amount of EUR 0,2 million can be made available for the COSME operational budget lines.

#### Increased 02 02 01

#### Promoting entrepreneurship and improving the competitiveness and access to markets of Union enterprises

The reinforcement by EUR 1,2 million in commitment appropriations will finance additional activities of the programme for the Competitiveness of Enterprises and Small and Medium-Sized Enterprises (COSME).

#### Increased 02 02 02

#### Improving access to finance for small and medium-sized enterprises (SMEs) in the form of equity and debt

It is necessary to reinforce the COSME financial instruments by EUR 1,2 million in payment appropriations since the Covid-19 crisis has triggered significant additional needs in payments for this budget line. The additional payment appropriations will ensure a smooth functioning of the Loan Guarantee Facility, including its dedicated Covid-19 support measure, which must continue its deployment urgently in 2020.

# Increased 02 04 02 01

# Leadership in space

The reinforcement by EUR 1,1 million in commitment and payment appropriations will fund additional eligible projects in the area of space research.

# Increased 02 05 01

#### Developing and providing global satellite-based radio navigation infrastructures and services (Galileo) by 2020

The reinforcement by EUR 1,8 million in commitment and payment appropriations will be used to improve the system resilience, as well as stability, availability and reliability of services and to launch activities linked to the transition ground segment of the Galileo second generation. Moreover, the decision to accelerate the procurement of the second generation of Galileo satellites resulted in the need to make payments to industry for a higher amount than initially foreseen.

# Increased 02 06 01

#### Delivering operational services relying on space-borne observations and in-situ data (Copernicus)

The reinforcement by EUR 0,4 million in commitment appropriations will be used mainly to cover the activities under the Framework Partnership Agreement signed with the German research centre for aeronautics and space (DLR). The reinforcement by EUR 0,4 million in payment appropriations will cover the payment of outstanding commitments and the pre-financing of Copernicus services managed through delegation agreements with different entities.

# Decreased 05 01 05 01

#### Expenditure related to officials and temporary staff implementing research and innovation programmes --Horizon 2020

The surplus of EUR 0,2 million derives from the revision of the actual needs considering the staff in place and the expected indexation on this salary line.

#### Decreased 05 01 05 03

#### Other management expenditure for research and innovation programmes -- Horizon 2020

This administrative line is dedicated to costs related to missions, external experts participating in workshops and/or comitology, or communication. Due to the Covid-19 outbreak, all activities are on hold since March 2020 and uncertainty continues for the remaining months of 2020. The resulting surplus of EUR 0,4 million can be made available for the operational line.

#### Increased 05 09 03 01

#### Securing sufficient supplies of safe and high quality food and other bio-based products

The reinforcement of EUR 0,6 million in commitment and payment appropriations will be used to fund additional beneficiaries in the areas of Sustainable Food Security, Blue growth, Rural Renaissance or Food and Natural resources, which have been (or would be) evaluated as with excellent potential but were put on the reserve list due to insufficient budget.

#### Increased 06 03 03 01

#### Achieving a resource-efficient, environmentally-friendly, safe and seamless European transport system

The reinforcement of EUR 0,4 million in payment appropriations will be used to cover the invoices to be received by the end of the year, which are slightly higher than the initial forecast.

# Executive Agency for Small and Medium-sized Enterprises -- Contribution from LIFE

Taking into account the impact of the Covid-19 crisis and the containment measures on the administrative expenditure, an amount of EUR 0,3 million in commitment and payment appropriations can be made available on the LIFE subsidy budget line.

#### Halting and reversing biodiversity loss

The reinforcement by EUR 0,3 million in commitment and payment appropriations will allow to fulfil the legal obligations by year-end, notably for renewal of contracts, especially in view of a potential delay of the new Multiannual Financial Framework and will contribute to a smooth and global execution of the LIFE Programme.

#### Executive Agency for Small and Medium-sized Enterprises -- Contribution from Horizon 2020

The Executive Agency for Small and Mediums-sized Enterprises has updated its needs to take into account the impact of the Covid-19 crisis and the containment measures on the administrative expenditure. Therefore, an amount of EUR 1,5 million in commitment and payment appropriations can be made available.

#### SME instrument

The reinforcement by EUR 1,5 million in commitment and payment appropriations will be used to fund additional projects under the SME instrument.

#### Other management expenditure for research and innovation programmes -- Horizon 2020

The travel restrictions due to the Covid-19 pandemic result in an underspending of mission and meeting budgets. Furthermore, the execution of some contracts for infrastructure works are delayed due to the sanitary crisis. Therefore, an amount of EUR 5,1 million can be made available.

#### Increased 10 02 01

#### Horizon 2020 -- Customer-driven scientific and technical support to Union policies

A reinforcement of EUR 5,1 million in commitment and payment appropriations is needed to cover the activities of the Joint Research Centre (JRC) to face the Covid-19 crisis: from the preparation of guidelines and control materials for testing and better characterization of the pandemics, to the detailed analysis on economic impact in different sectors such as agriculture, energy supply, transport. The JRC is working to evaluate and anticipate the evolution of this crisis to effectively manage it. An example in this respect is the web platform Re-open EU, which was launched by the JRC to safely resume free movement and tourism in the European Union. Continuous support is provided to international institutions including the World Health Organisation for the development and adaptation of the Epidemic Intelligence from Open Sources (EIOS) platform for the monitoring of the Covid-19 crisis.

Taking into account the impact of the Covid-19 crisis and the containment measures on the administrative expenditure, an amount of EUR 0,2 million in commitment and payment appropriations can be made available .

#### Governance and communication

Following the re-assessment of the payment forecast until year-end, the reinforcement of EUR 0,2 million in payment appropriations will cover the additional needs on this line, in particular the financing of the Advisory Councils.

#### European Maritime and Fisheries Fund (EMFF) -- Operational technical assistance

The reinforcement of EUR 0,2 million in commitment appropriations will be used to extend the on-going contracts in order to ensure continuity of service until new contracts are signed.

#### Expenditure relating to officials and temporary staff implementing research and innovation programmes --Horizon 2020

Due to Covid-19 outbreak and the subsequent confinement period, there were delays in recruitment and hence, an amount of EUR 0,2 million can be made available for transfer to the operational line.

#### External personnel implementing research and innovation programmes -- Horizon 2020

Due to Covid-19 outbreak and the subsequent confinement period, there were delays in recruitment and hence, an amount of EUR 40 000 can be made available for transfer to the operational line.

# Marie Sklodowska-Curie actions -- generating, developing and transferring new skills, knowledge and innovation

The reinforcement of EUR 0,2 million in commitment and payment appropriations will cover a higher number of prefinancing payments on the call for proposals ITN-2019.

#### Decreased 18 01 04 03

#### Support expenditure for the programme `Europe for citizens`

The appropriations on this budget line were mainly foreseen for events. Due to the Covid-19 pandemic, no events could be organised and an amount of EUR 0,1 million can be made available.

#### Decreased 18 01 04 05

#### Support expenditure for emergency support within the Union

An amount of EUR0,3 million can be made available due to cost savings generated by using internal expertise instead of reaching out for external competence.

#### Decreased 18 01 05 01

#### Expenditure related to officials and temporary staff implementing research and innovation programmes --Horizon 2020

The exceptional surplus of EUR 0,4 million is related to a retirement without immediate replacement, vacant positions despite high effort in the recruiting procedure and special working arrangements (part time, parental leave).

#### Other management expenditure for research and innovation programmes -- Horizon 2020

The Covid-19 outbreak has impacted the budget for the organisation of events, missions, hospitality and the reimbursement of travel cost for national experts/contact points. The exceptional surplus of EUR 0,2 million is caused mainly by the transformation of meetings and workshops of the Community of Users from physical events into virtual events. The reduction of commitments for missions, hospitality and reimbursement of travel/accommodation costs for national experts has led to further savings.

# Europe for citizens -- Strengthening remembrance and enhancing capacity for civic participation at the Union level

The reinforcement by EUR 0,1 million in commitment and payment appropriations will be used in particular for Civil society projects, where the number of applications has increased by 40% compared to 2019.

#### Fostering secure European societies

The reinforcement of EUR 0,6 million in commitment and payment appropriations will be used to support the security priorities, including border protection, where the value of project proposals received in the area of security is increasing from year to year and the oversubscription is high (in 2019 only 14% of the value of the submitted proposals was covered by the available budget).

#### Emergency support within the Union

With the worsening of the Covid-19 situation in Europe, it is reasonable to believe that there will be in an increasing need for transfer of patients and transport of medical personnel. The reinforcement of EUR 0,3 million in commitment and payment appropriations will cover additional needs for such operations, as well as for cargo transport of medical equipment.

#### Other management expenditure for research and innovation programmes -- ITER

Due to the Covid-19 crisis, there is a decrease of the budget needed for missions, events and experts. In addition, some other actions are cancelled or postponed. An amount of EUR 0,4 million in commitment appropriations can be made available for transfer to the operational line.

#### Nuclear safeguards

Due to the Covid-19 crisis, there is a decrease of the budget needed for the inspection missions. In addition, some expenses were initially foreseen for the potential renewal of contracts in case of an extension of the transitory period with the United Kingdom, but it is now clear that the transition period will finish at the end of 2020. Therefore, an amount of EUR 0,3 million in commitment appropriations can be made available.

# Construction, operation and exploitation of the ITER facilities -- European Joint Undertaking for ITER -- Fusion for Energy (F4E)

A few commitments for the buildings and key components of the ITER project needed to be brought forward to 2020 in order to safeguard the schedule of the first plasma and facilitate the negotiation of the contracts. Some commitments related to the Design and Construction of the Emergency Power Supply Distribution for the buildings originally planned for 2022 are now scheduled for November 2020. Therefore, a reinforcement of EUR 0,7 million in commitment appropriations is needed.

#### Support expenditure for the Consumer programme

The meetings foreseen on this budget line have been cancelled due to the Covid-19 pandemic, and an amount of EUR 0,1 million in commitment and payment appropriations can be made available.

#### Increased 33 04 01

#### Safeguarding consumers-- interest and improving their safety and information

The reinforcement of EUR 0,1 million in commitment and payment appropriations is needed, as the planning of the remaining 2020 actions goes beyond the remaining budget.
