On 28 October, the Permanent Representative Committee (Part 2) recommended the Council to adopt the Council Decision on the signing, on behalf of the European Union, and provisional application of the Agreement amending the Interim Partnership Agreement between the European Community, of the one part, and the Pacific States, of the other part, as regards the accessions of the Independent State of Samoa and Solomon Islands, and of future accessions of other Pacific Island States, as set out in documents 11656/20 and 11669/20 (see document 12150/20), and to decide to forward the draft Council Decision on the conclusion of the agreement amending the Interim Partnership Agreement between the European Community, of the one part, and the Pacific States, of the other part, as regards the accession of the Independent State of Samoa and Solomon Islands, and of future accessions of other Pacific Island States, and set out in documents 11657/20 and 11669/20 (see document 12152/20) to the European Parliament for its consent.
