#### d) Detailed grounds for the decrease

The budget implementation of the 2019 Work Programme for Civil Protection is lower than initially planned due to the following difficulties encountered:

- Late approval of the amending decision on 21/03/2019, which led to a later start of the implementation of the different activities related to the plan to strengthen EU civil protection response to disasters (rescEU);
- Major modifications in the amending decision impacting the execution of the programme:
  - Ownership of the assets (e.g. rescue planes) by the EU as proposed by the Commission was replaced by ownership by Member States (MS). As a consequence, the Commission does not procure rescEU capacities directly: procurement takes place with the Member States and can be launched only when a Member State has completed the decision to buy such assets, increasing dramatically the time to market;
  - Obligation to define rescEU capacities in implementing acts before implementation. Consequently, the Commission and MS experts are involved in an intermediary step beforehand, consisting in detailed technical discussions. To date, needs in the field of aerial forest firefighting have been identified and the implementing decision adopted. An implementing act on emergency medical response capacities and a consolidation of previous implementing decisions are already under preparation;
- Budget implementation is highly dependent on preparedness and resolution of MS administrations to participate, issuing valid proposals. The Commission is supporting and encouraging them in the phasing in and is confident that more concrete projects will soon be approved.

### d) Detailed grounds for the decrease

The use of the response capacities of Union Civil Protection Mechanism fully depends on the magnitude of emergencies (notably forest fires) occurring during the year. This is unpredictable by nature.

2019 has experienced a low level of emergencies which translated into a low number of transports interventions requests and hence, a lower demand and implementation of the EU budget.

### d) Detailed grounds for the increase

Resettlement is a priority of the EU and has shown very encouraging results: the on-going '50 000' resettlement scheme expiring end 2019 shows that 37 520 people were resettled under the scheme as of 6 September 2019, a 75% implementation rate. Additional pledges are currently under discussion with Member States.

The proposed reinforcement of EUR 45 million will complement the already identified availabilities for resettlement in the 2019 and 2020 budgets, thus ensuring the financing of the additional resettlement pledges.
