TRANSFER OF APPROPRIATIONS N° DEC 26/2020

INTRODUCTION

The project of construction, handover and sale of the JMO-2 building was submitted to the budgetary authority in October 2012.

The construction of the new building is carried out by the Luxembourg State under the terms of the "Framework contract for the pre-financing, construction, making available and sale of an administrative complex to replace the Jean Monnet Building in Luxembourg-Kirchberg" signed on 29 July 2013 between the Commission, the Grand Duchy of Luxembourg and the 'Fonds d'Urbanisation et d'Aménagement du Plateau du Kirchberg' (FUAK).

The framework contract foresees (Article 8) that: "At any time after the signature of this framework contract, the Commission may make advance payments. If payments are made before the date of transfer of ownership of the building, they shall be deducted from the "Final Price of the project" as referred to in Article 5(1)(4)."

Moreover, in its opinion delivered on 24 January 2013, the European Parliament, in particular:

- 1. "Insists, having regard to the large budgetary impact of the project, on strict respect of advance payments of a minimum of EUR 120,0 million within the pre-financing period";
- 2. "Urges fulfilment of the Commission's commitment to make advance payments above the minimum of EUR 120,0 million between 2015 and 2024 in order to further reduce the burden of interest and overall costs, thus reducing the final project costs to be reimbursed".

In August 2018¹ the Commission informed the budgetary authority of the development of the JMO-2 project, and obtained agreement on an increase in costs following the updating of the project and the integration of new security measures. The new cost of the project now amounts to EUR 442,8 million (index October 2017).

In the same document, the Commission confirmed its intention to make advance payments to the Luxembourg State with the administrative appropriations remaining unused at the end of each financial year, which will reduce annual instalments due in future.

As indicated in the Working Document Part VII (Commission Buildings) of the Draft General Budget of the European Union for the Financial Year 2021, the Commission has already made three advance payments in 2017, 2018 and 2019 for a total amount of EUR 62 559 289. The present transfer of appropriations will allow the Commission to carry out a forth advance payment to the Luxembourg State at the end of 2020 for an amount of EUR 40 729 941 which will bring the total amount of advance payments to EUR 103 289 230.

The amount to be redeployed results from a lower than anticipated salary indexation as from 1 July 2020.

In accordance with articles 64 and 65 of the Staff Regulations, the remuneration of the officials and other servants of the European Union is updated each year, in the light of a report presented by the Commission, based on statistical data prepared by Eurostat in agreement with the national statistical offices of the Member States, reflecting the situation in the Member States at 1 July.

The calculation of the update is based on the principle of parallelism between the evolution of real (net of inflation) remuneration of Union officials and national civil servants of the Member States. It reflects the combined effect of two main variables:

- The specific indicator (SI), reflecting the changes in the purchasing power of salaries of national civil servants in central governments of a sample of 11 Member States representing more than 75% of the Union Gross Domestic Product (GDP);
- The joint index (JI), reflecting the annual inflation in Brussels and Luxembourg calculated by weighting national consumer price inflation as measured by the Belgium Harmonised Index of Consumer Prices (HICP) and Luxembourg Consumer Price Index (CPI) according to the distribution of Union staff serving in those Member States.

Those two elements are multiplied in order to obtain the update rate.

As stipulated in Article 11 of Annex XI to the Staff Regulation ('exception clause'), in case of a decrease in the real Union GDP for the current year as forecast by the Commission and the specific indicator is positive, only part of the specific indicator shall be used to calculate the value of the update. In the case of a drop of the GDP by more than 3%, the specific indicator will be set to 0% for the 2020 exercise. The value of the specific indicator that did not serve the update of the remunerations and the pensions in 2020, shall form the basis of the calculation of a future update once the cumulative increase of the Union GDP becomes positive.

According to the latest forecast issued by the Commission, as a consequence of the COVID-19 crisis, the real EU GDP in the calendar year 2020 is expected to decrease by 8,3%. Therefore, the exception clause will be triggered and the specific indicator will be 0% and the salary update on 1 July 2020 will solely correspond to the evolution of the Joint Index (JI) for the period July 2019-July 2020.

This JI has been confirmed at 0,7% by Eurostat in the report for the annual update of remunerations and pensions issued on 31 October 2020, in line with the provisions set out in Annex XI of the Staff Regulations, whereas the revised forecasted salary update rate as of 1 July 2020 used for the Budget 2020 (6 months impact) was 2,5%.
