The Schengen associated countries should participate in the discussions concerning the parts of the proposals which constitute the development of the Schengen acquis. Whenever possible, discussion on those parts of the proposals will take place separately, in the COMIX format. Regarding the above agenda item on which a separate discussion on the Schengen related aspects is not possible for the time being, the Schengen Associated Countries are invited to participate to this discussion on an exceptional basis. The Council Legal Service is examining the Schengen relatedness of the Commission proposals and will come back with detailed analysis on this question as soon as possible.
