Committee of the Regions (CoR); Nomination of Bürgermeisterin Bernadette Schöny as an alternate member of the CoR

Pursuant to Article 305 TFEU, the Council appoints members and alternate members of the CoR for five years on the basis of a proposal made by each Member State. Where the term of office of a member or an alternate member is terminated before expiry of that period, a replacement is appointed for the remaining term of office by the same procedure.

Dr Carmen Kiefer, Vizebürgermeisterin of Kuchl in Salzburg, resigned her mandate as alternate member with effect from 3 July 2020 and was subsequently appointed as a member.

On 26 October 2020, the Austrian Federal Government therefore decided to nominate Ms Bernadette Schöny, Bürgermeisterin of Kaltenleutgeben in Lower Austria, as alternate member of the CoR (replacing Vizebürgermeisterin Carmen Kiefer).

Please find enclosed the details of the nominee in the form requested by the General Secretariat of the Council.

I would kindly request that you draw up the appointment decision for the earliest possible Council meeting.
