General Statement

(submitted in writing)

Chair,

- Germany is honoured to take the floor on behalf of the European Union and its Member States. We look forward to working efficiently under the able guidance of you and your Vice-Chairs during this week.
- 2. The EU and its Member States remain committed to further progress in the field of IP and development, particularly in light of the United Nations 2030 Agenda for Sustainable Development. We support the continued implementation of the 45 Development Agenda Recommendations in a balanced and consensus-driven manner and are pleased that this Committee is able to continue its important work, after it had to be postponed in May due to the crisis. Against this background, we would like to thank the WIPO Secretariat for their excellent work in preparing and organising this first CDIP session in a hybrid format.
- 3. The EU and its Member States welcome the Reports under agenda item 6 on the implementation of Development Agenda Recommendations. We are pleased to take note that the Development Agenda Recommendations have been further implemented and mainstreamed into WIPO's regular program activities and into the work of other WIPO bodies. According to Part II of the Director General's Report, contained in document CDIP/25/2, WIPO completed and evaluated 34 DA projects to date. We see this considerable number as a great success of the Committee's hard work.

- 1. The EU and its Member States would like to thank the WIPO Secretariat for preparing the Report on WIPO's Contribution to the Implementation of the Sustainable Development Goals and its Associated Targets contained in document CDIP/25/6. The report provides a well-structured and comprehensive overview and update on WIPO's activities undertaken individually or as part of the UN system.
- 2. The EU and its Member States acknowledge the high value of WIPO's contribution to the implementation of the SDGs and the associated targets which is guided by the Development Agenda. We continue to be fully committed to supporting the achievement of the SDGs, as they are important and relevant to all countries in the world.
- 3. The health related activities and initiatives mentioned in the report have particularly caught our attention, such as 'WIPO Re:Search' and The Patent Information Initiative for Medicines (Pat-Informed). We would be very interested to learn more about the suitability of these activities and initiatives to contribute to the current global health crises and how they might be linked to current WHO initiatives aimed at finding a vaccine. Chair,

- 1. The EU and its Member States appreciate the reports on the webinars on technical assistance and we would like to thank the Secretariat for having launched a series of webinars, contained in document CDIP/25/3, in order to facilitate discussions on the usefulness of the webinar platform.
- 2. Coming to the independent evaluation report, contained in document CDIP/25/4, first of all we would like to express our gratitude for this report to the independent consultant Ms Lois Austin. By assessing three main criteria (1. Relevance, 2. Effectiveness and 3. Sustainability) and presenting a set of 6 recommendations on the basis of the evaluation findings to each of the criteria, this report is well-structured and comprehensive.
- 3. As already expressed, technical assistance is central and should remain in the heart of this Committee's work. Therefore we note with satisfaction that the report is generally positive about the webinars on technical assistance.
- 4. Referring to Recommendation 3 of the evaluation report, recommending that webinars should be considered only as a complementary activity to more traditional approaches, we should bear in mind the current global health crises. In light of travelling restrictions and quarantine instructions, we see advantages in having webinars instead of more traditional approaches such as WIPO in-country missions. Against this background, we particularly consider that webinars are worth developing.

5. However, the EU and its Member States see this report as a proof for the usefulness of the webinar platform and we would like to see the webinar platform continued by taking into account in an appropriate manner the 6 recommendations of the evaluation report. Therefore, we would be pleased to know how the Secretariat envisages to proceed on the basis of the said report and we stand ready for further discussions under this topic.
