The SCA confirmed the Union position reached by consensus in the Working Party on the eight draft resolutions of Union competence that will not have legal effects if adopted by the OIV, by taking note of point 5 of the report in document 11840/20.

The SCA considered the draft Council Decision contained in document 11843/20 and invited the Council to adopt it by written procedure to be first agreed by Coreper on 18 November; and to inform the European Parliament of its Decision in accordance with Article 218(10) of the Treaty on the Functioning of the EU.

The SCA took note of: i) the information provided by the Commission, including in document WK 10899/2020, regarding the practices that Member States could support under the eco-schemes; ii) the information from the Commission on the calculation of eco-scheme payments, in particular of those based on Article 28(6)(a), and of delegations' comments; iii) delegations' questions and comments on these matters, as well as of the Commission's replies.

The Presidency would follow-up on delegations' requests to organise a meeting of the Working Party on Horizontal Agricultural Questions on technical aspects linked to the design of eco-schemes. The exact date would need to be identified.
