Statement by Hungary

Hungary remains dedicated to its human rights commitments, including the protection and promotion of women's rights and equality between women and men.

Hungary recognizes and promotes equality between women and men in accordance with the Fundamental Law of Hungary, principles and values of the European Union, as well as commitments and principles stemming from international law. Furthermore equality between women and men is enshrined in the treaties of the European Union as a fundamental value. In line with these and its national legislation, Hungary interprets the concept of "gender" as reference to sex and concept of "gender equality" as reference to the equality between men and women.

Hungary notes, that the term of "all gender" is lacking definition at international level, including within the European Union. Therefore, Hungary is not in the position to support the text.
