Acting in accordance with a special legislative procedure,

Whereas:

- (1) Regulation (EU) .../...+ of the European Parliament and of the Council¹ establishes an exchange, assistance and training programme for the protection of the euro against counterfeiting (the 'Pericles IV programme') that is applicable in the Member States in accordance with the Treaties. Article 139 of the Treaty on the Functioning of the European Union provides that measures governing the use of the euro referred to in Article 133 thereof shall not apply to the Member States with a derogation.
- The exchange of information and staff and the assistance and training measures implemented under the Pericles IV programme should however be uniform throughout the Union. The requisite measures should therefore be taken to ensure the same level of protection for the euro in the Member States that do not have the euro as their official currency,

HAS ADOPTED THIS REGULATION:

The application of Regulation (EU) .../...⁺ shall be extended to Member States other than the participating Member States as defined in point (a) of Article 1 of Council Regulation (EC) No 974/98¹.

Entities from those Member States shall be considered eligible for funding when they are competent authorities within the meaning of Article 9 of Regulation (EU) .../...+.

Council Regulation (EC) No 974/98 of 3 May 1998 on the introduction of the euro (OJ L 139, 11.5.1998, p. 1).

Article 2

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

It shall apply from 1 January 2021.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
