*Presidency briefing on the outcome of the trilogues  
Exchange of views*

The SCA took note of the information provided on the outcome of the trilogues that took place on 1, 2 and 4 December on the CAP Strategic Plans, CMO and Horizontal Regulations respectively; the SCA also took note of delegations' and the Commission's positions;

The SCA exchanged views on how specific the CAP Strategic Plans Regulation should be on the fields covered by the eco-schemes, the possibility of including an indicative open list of eco-schemes and a point system. The Presidency would take on board the comments expressed for the next trilogue scheduled on 10 December and would report back to the SCA.

### 4. Organisation of future work

The Presidency informed the SCA about the "Agriculture and Fisheries" Council meeting on 15-16 December 2020, and of their intention to table an AOB at that Council meeting on the 48th Conference of Directors of the EU Paying Agencies, which took place by videoconference on 8-9 October.

The incoming Portuguese Presidency informed the SCA about the next SCA meeting on 11 January 2021.

### 5. Planned Delegated act on the taxonomy of economic activities for the purposes of climate change mitigation and adaptation

*Information from the Croatian delegation*

The Croatian delegation expressed concerns about the planned delegated act on the taxonomy of economic activities for the purposes of climate change mitigation and adaptation, fearing that it could prejudge decisions to be taken as part of the CAP reform. It requested a discussion on the issue at a forthcoming SCA meeting.
