## CZECH REPUBLIC

### Bilateral agreements on police cooperation with neighbouring countries – overview

The Czech Republic has concluded bilateral international agreements on police cooperation with a number of countries, both European and non-European. However, within the field of international cooperation on combating crime, agreements concluded with countries directly neighbouring with Czech Republic, which are the Federal Republic of Germany (DE), the Republic of Poland (PL), the Slovak Republic (SK) and the Republic of Austria (AT), play a key role.

In terms of material scope, generally the purpose of all four police cooperation agreements with neighbouring states is to intensify cooperation on combating crime and the protection of public order. Treaties concluded with SK and PL contains a demonstrative list of types of crimes in the fight against which the contracting parties cooperate. Treaties concluded with AT and DE are lacking such list, but at the same time none of those treaties contain a provision that would limit the possibility of cooperation to specific types of crimes. When it comes to cooperation in the field of administrative offences, according to the treaty concluded with AT, it is possible to cooperate if offences were committed by persons;

cooperation under the treaty concluded with DE is possible in the field of administrative offences within the competence of police or customs authorities. Treaties concluded with SK or PL does not allow such cooperation in the field of administrative offences.

In terms of territorial scope, in case of AT, SK and PL, treaties cover the entire territory of the state, but they also contain special provisions concerning border areas. In the treaty with DE, the regional character is abandoned and cooperation be basically realized throughout the entire territory of both countries – the possibility of direct cooperation of border regions authorities remains unaffected, whereas the border area of DE extends to the entire territory of the Free State of Saxony and the Free State of Bavaria.

Treaties contain regulations of various forms of cross-border operations – in particular joint patrols, participation in interventions, cross-border search operations, joint control groups or crime prevention programs. They provide for the possibility of support from the staff of the other contractual party or cooperation in ensuring the security in railway transport. The treaties concluded with AT and DE explicitly regulate cooperation in the transfer of persons, carrying out of transits and in the measures in the event of imminent danger. In addition, the treaty concluded with DE also contains provisions concerning the escorts of non-standard cargos, the passage of police officers through the territory of another state or cooperation during the temporary reestablishment of internal border control.

Treaties with all four neighbouring countries contain provisions relating cross-border hot pursuit, whereas treaty concluded with AT is the only one that contains provisions relating judicial assistance and thus also cross border surveillance.

All four treaties allow the secondment of a liaison officer to the other contracting country. Furthermore, all four treaties also contain provisions regulating the basic principles of personal data protection relating the personal data transferred during the cooperation under these treaties.

All four treaties also include provisions regulating the legal status and competencies of officers operating within the territory of the other state during the cooperation under these treaties, including the competence to wear a uniform, to carry a service firearm, but also to use this firearms or coercive means under strictly specified conditions.
