Having regard to Decision No 3/2006 of the ACP-EC Committee of Ambassadors of 27 September 2006 on the Financial Regulation of the Technical Centre for Agricultural and Rural Cooperation (CTA)⁴, in particular Article 26(5) thereof,

Having regard to the financial statements of the Technical Centre for Agricultural and Rural Cooperation for the financial year 2019 that ended on 31 December 2019,

Having regard to the Auditors' reports on the financial statements for the financial year 2019,

Having taken note of the approval of the financial statements of the Technical Centre for Agricultural and Rural Cooperation for the financial year 2019 by the Board of the Centre, based on the examination of the audit report,

Whereas:

- The revenue of the Centre for the financial year 2019 consisted principally of contributions from the European Development Fund, amounting to EUR 19 622 000 on a total of EUR 21 760 000.
- (2) The Director's overall implementation of the Centre's budget during the financial year 2019 were such that the Director should be given a discharge in respect of the implementation of that budget,
