Confirmation of the final text with a view to agreement

<u>The SCA</u> noted that all delegations supported the Commission proposal regarding financial discipline as from 2021 and flexibility between pillars for 2020 without amendments, as set out in document 13644/19 + ADD1.

<u>The SCA</u> mandated the Presidency to send a letter to the European Parliament informing it that an agreement in first reading could be reached on the Commission proposal without amendments, provided that the Parliament agreed to adopt its position in the form of the Commission proposal. The text would be submitted to a legal-linguistic review with a view to its later approval by the SCA and adoption by the Council.

The SCA exchanged views on a Presidency paper on direct payments set out in document 13750/19. The SCA also took note of delegations' and the Commission's comments on it. The Presidency noted that there was broad support for the proposed drafting suggestions and would incorporate them in a consolidated text. Further consideration would be given in particular to redistributive payments in Article 26(2a), on the basis of delegations' comments.

The SCA also exchanged views on a Presidency paper on sectoral types of interventions set out in document 14288/19. The SCA took note of delegations' and the Commission's comments on it. The Presidency noted that a majority of delegations supported the alternative approach set out in the Presidency paper with regard to forms of cooperation under types of interventions for 'other sectors', subject to further legal drafting.
