Thank you for your request for access to documents of the Council of the European Union.¹

Please find attached a partially accessible version of document 14620/18.²

However, I regret to inform you that full access cannot be given for the reasons set out below.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Article 4(6) of Regulation (EC) No 1049/2001.

Document 14620/18, dated 14 December 2018, comprises an opinion of the Council Legal Service, on the Commission proposal for a Directive of the European Parliament and of the Council on the protection of persons reporting on breaches of Union law ("whistleblowers" proposal). The requested opinion provides detailed analysis on the legal bases of the proposal and therefore contains legal advice.

The decision-making process in question has not been finalised to date and the subject legislative act has not yet been adopted. In addition, the issues analysed in the requested opinion are complex and have formed an important part of the basis for the discussions on the legislative file. Under these circumstances, disclosure of the legal advice at this stage would risk compromising the capacity to reach a final decision on the dossier and thus undermine the decision-making process pursuant to Article 4(3) of Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents.

Moreover, the legal advice covered by this opinion deals with issues which are particularly wide in scope and contentious. In particular, the analysis on the question of the appropriate legal bases for the proposal provided in the requested opinion goes beyond the legislative file in question and could be transposed in other similar contexts. The legal advice is therefore sensitive. In light of the above, disclosure of the requested document would undermine the protection of legal advice under Article 4(2), second indent, of Regulation (EC) No 1049/2001. It would make known to the public an internal opinion of the Legal Service, intended for the members of the Council. The possibility that the legal advice in question be disclosed to the public may lead the Council to display caution when requesting similar written opinions from its Legal Service. Moreover, disclosure of the legal advice could also affect the ability of the Legal Service to effectively defend decisions taken by the Council before the Union courts. Lastly, the Legal Service could come under external pressure which could affect the way in which legal advice is drafted and hence prejudice the possibility of the Legal Service to express its views free from external influences.

As regards the existence of an overriding public interest in disclosure, the General Secretariat considers that, on balance, the principle of transparency which underlies Regulation (EC) No 1049/2001 would not, in the present case, prevail over the above indicated interests so as to justify full disclosure of the requested document.

In the view of the foregoing, the General Secretariat of the Council is unable to grant you full access to this document. However, in accordance with Article 4(6) of Regulation (EC) No. 1049/2001, you may have access to its paragraphs 1, 4 (with the exception of footnote 7) and 5 to 11 to which public access has already been granted.

You can ask the Council to review this decision within 15 working days of receiving this reply (confirmatory application).³
