Regulation on common market organisation (CMO) of agricultural products

*Exchange of views*

The SCA exchanged views on the elements presented in doc. 14224/2020 REV 1. The Presidency took note of the views of delegations and revised the classification of certain amendments to reflect the position of the majority. The Council's classification of Block 1 amendments to the CMO Regulation would serve as a guide with a view to engaging in negotiations with the European Parliament. The Presidency will communicate the updated table with the Council's position to the European Parliament and will inform the SCA in parallel.
