## 'I' ITEM NOTE

Subject: Council recommendations on the discharge to be given to the bodies set up under the TFEU and the Euratom Treaty in respect of the implementation of the budget for the financial year 2019  
– *Adoption*

---

1. In accordance with Regulation (EU, Euratom) 2018/1046<sup>1</sup>, and in particular Article 70(4) thereof, the Council is required to draw up recommendations to the European Parliament on a discharge to be given to the bodies set up under the TFEU and the Euratom Treaty and which have legal personality and receive contributions charged to the budget.
2. At its informal videoconference on 11 January 2021 and its meetings on 28 January and 4 February 2021, the members of the Budget Committee examined the thirty-two specific annual reports<sup>2</sup> of the European Court of Auditors related to bodies set up under the TFEU and the Euratom Treaty, having legal personality and receiving contributions charged to the budget, and reached an agreement on the draft texts as set out in the Addendum.

  - decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision 2020/430<sup>3</sup>, as further extended by Council Decision 2021/26<sup>4</sup>, that the Council uses the written procedure for the adoption of the draft recommendations, as set out in the Addendum to this note; and
  - arrange for the above mentioned Council recommendations to be forwarded to the European Parliament and approve the draft letter in the Annex to that effect.
