Exchange of views

The SCA exchanged views on social conditionality on the basis of a working document with the number 5841/21. The Presidency will take on board the comments expressed in the ongoing trilogue discussions with the European Parliament on the CAP Strategic Plans Regulation.

The SCA exchanged views on possible compromise solutions identified in the context of the second trilogue on the CMO Regulation, namely on the extension of the planting authorisation scheme, the forbidden vine varieties and on dealcoholized and partially dealcoholized wines on the basis of a working document with the number 5898/21. The Presidency will take on board the comments expressed in the ongoing trilogue discussions with the European Parliament on the CMO Regulation.
