Statement by Hungary

"Hungary has expressed concerns as regards the draft regulations establishing the Rights and Values programme and the Justice programme for the period 2021-2027 several times during the negotiations, and cannot support the text of the final political agreement reached with the European Parliament either.

Concerning the draft regulation establishing the Rights and Values programme for the period 2021–2027 and the draft regulation establishing the Justice programme for the period 2021-2027, Hungary is of the opinion that deficiencies as regards the legal basis (especially concerning the 'Union values' strand, as well as the 'Citizens engagement and participation' strand of the Rights and Values programme), the blurred scope not limited to the field of application of Union law (including references to international treaties not ratified by the Union), the focus on the support of one specific type of eligible entities (civil society organisations), instead of focusing on the substantial projects, as well as the reference to concepts which are not in line with the language of the Treaties would have made a substantial revision of the draft regulation necessary. Hungary is firmly committed to the protection of fundamental rights and European values, including the promotion of civil society and equal treatment.

Hungary maintains that basic requirements of legal certainty, principle of conferral and compliance with the Treaties in general shall be respected in order to prevent the impression that political and ideological views could have an impact, when defining the priorities of EU funding."

Statement by Hungary

"Hungary has expressed concerns as regards the draft regulations establishing the Rights and Values programme and the Justice programme for the period 2021-2027 several times during the negotiations, and cannot support the text of the final political agreement reached with the European Parliament either.

Concerning the draft regulation establishing the Rights and Values programme for the period 2021–2027 and the draft regulation establishing the Justice programme for the period 2021-2027, Hungary is of the opinion that deficiencies as regards the legal basis (especially concerning the 'Union values' strand, as well as the 'Citizens engagement and participation' strand of the Rights and Values programme), the blurred scope not limited to the field of application of Union law (including references to international treaties not ratified by the Union), the focus on the support of one specific type of eligible entities (civil society organisations), instead of focusing on the substantial projects, as well as the reference to concepts which are not in line with the language of the Treaties would have made a substantial revision of the draft regulation necessary. Hungary is firmly committed to the protection of fundamental rights and European values, including the promotion of civil society and equal treatment.

"As regards the Regulation extending the Pericles IV Programme to non-participating Member States we would like to draw the attention to the fact that the German representative in the Council will only be able to agree to this Regulation when a national parliamentary law which allows to agree to this Regulation has come into force. We will inform the Presidency as well as the General Secretariat of the Council accordingly and as soon as possible and would like to ask for the formal adoption procedure to be initiated only then."
