# d) Detailed grounds for the decrease

According to article 9 of the Multiannual Financial Framework Regulation<sup>1</sup>, the Solidarity and Emergency Aid Reserve (SEAR) is intended to allow for

- (a) assistance to respond to emergency situations resulting from major disasters that are covered by the European Union Solidarity Fund, the objectives and scope of which are set out in Council Regulation (EC) No 2012/2002; and
- (b) rapid responses to specific emergency needs within the Union or in third countries following events which could not be foreseen when the budget was established, in particular for emergency responses and support operations following natural disasters not covered by point (a), man-made disasters, humanitarian crises in cases of large-scale public health, veterinary or phytosanitary threats, as well as in situations of particular pressure at the Union's external borders resulting from migratory flows, where circumstances so require.

Point 10 of the Interinstitutional Agreement of 16 December 2020 between the European Parliament, the Council of the European Union and the European Commission on budgetary discipline, on cooperation on budgetary matters and on sound financial management, as well as on new own resources, including a roadmap towards the introduction of new own resources (IIA), lays down the modalities for the mobilisation of the European Union Solidarity Fund (EUSF) in the context of the SEAR.

#### d) Detailed grounds for the increase

The reinforcement of EUR 414,5 million in commitment and in payment appropriations is necessary to cover the needs arising from the Commission proposal to mobilise the European Union Solidarity Fund (EUSF):

1) for the applications presented by Greece and France in response to four regional natural disasters (floods, cyclone lanos, earthquake, storm Alex) in 2020. In line with the EUSF Regulation, the amount of the advances has been taken into account for calculating the balance of the contributions to the aforementioned Member States. The total amount for the balance payments of these four applications is EUR 78,1 million;

2) for the applications presented by Austria, Belgium, Croatia, Czechia, Estonia, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Portugal, Romania and Spain in response to the major public health emergency caused by the Covid-19 pandemic in early 2020. In line with the EUSF Regulation, the amount of the advances has been taken into account for calculating the balance of the contributions to the aforementioned Member States. The total amount for the balance payments to the above mentioned Member States is EUR 384,4 million, of which EUR 336,4 million are covered by the present transfer, and EUR 48 million are covered by the Commission proposal to carry over to 2021 the EUSF reserve not mobilised under the previous MFF (Draft Amending Budget 2).
