Whereas:

- (1) In it Decisions of 9 April 2019², 6 June 2019³ and 8 July 2019⁴ the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
