1. The General Secretariat of the Council has been informed of the resignation of Ms Riitta WÄRN, as alternate member of the Management Board of the above Agency in the employers' representatives category (for Finland).
2. Under Article 4 of Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94<sup>1</sup>, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019<sup>2</sup>, 6 June 2019<sup>3</sup> and 8 July 2019<sup>4</sup> the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Riitta WÄRN.
- (3) The employers' organisation BusinessEurope has nominated a candidate for the vacant seat,
