**DRAFT AMENDING BUDGET No 3  
TO THE GENERAL BUDGET 2021**

**ENTERING THE SURPLUS OF THE FINANCIAL YEAR 2020**

Having regard to:

- the Treaty on the Functioning of the European Union, and in particular Article 314 thereof, in conjunction with the Treaty establishing the European Atomic Energy Community, and in particular Article 106a thereof,
- Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union (...) <sup>1</sup>, and in particular Article 18 and Article 44(1)(a) thereof,
- the general budget of the European Union for the financial year 2021, as adopted on 18 December 2020 <sup>2</sup>,
- draft amending budget No<sup>o</sup>1/2021 <sup>3</sup>, adopted on 22 January 2021,
- draft amending budget No<sup>o</sup>2/2021 <sup>4</sup>, adopted on 24 March 2021,

The European Commission hereby presents to the European Parliament and to the Council Draft Amending Budget No 3 to the 2021 budget.

## EXPLANATORY MEMORANDUM

Draft Amending Budget (DAB) No 3/2021 is intended to enter in the 2021 budget the surplus resulting from the implementation of the budget year 2020. As provided for in Article 18(3) of the Financial Regulation applicable to the general budget of the Union<sup>5</sup> (“Financial Regulation”), the surplus is the only subject of this DAB and it has to be submitted within 15 days of the submission of the provisional accounts at the end of March 2021.

1. The implementation of the budget year 2020 shows a surplus of EUR 1 768 617 610, which is therefore entered as revenue in the 2021 budget.

2. Budgeting the surplus will reduce the total contribution of the Member States to the financing of the 2021 budget accordingly. The contributions by Member States will also be influenced by the revised own resources forecast which will be available after the meeting of the Advisory Committee on Own Resources later in 2021 and will be included in a subsequent Draft Amending Budget in accordance with Article 44(1)(b) of the Financial Regulation.

4. The combined net variations in Title 1 (*Own Resources*) and Title 3 (*Surpluses, balances and adjustments*) totals EUR 1 375 million. The additional amount budgeted for exchange rate differences (under title 3) more or less covers the shortfall in VAT and GNI own resources under title 1. Therefore, the surplus is predominantly driven by a higher than expected collection of customs duties.
5. The variations in Title 7 (*Default interest and fines*) amounts to EUR 268 million, which comprises competition fines and default interest, other penalty payments and interest linked to fines and penalty payments.

7. The Commission implemented 99,9 % of the authorised payment appropriations. The amount not implemented was EUR 101 million, of which EUR 62 million under Heading 5 - Administration that is attributable to the exceptional circumstances prevailing in relation to the COVID-19 pandemic, which had a direct impact on the number of missions, meetings, traineeships and recruitments.
8. The under-implementation of the other institutions of EUR 120 million is slightly higher than in 2019 (EUR 82 million).
