

The Council exchanged views on the main open issues, particularly on targeting of support. <u>The Presidency</u> would take into account the comments from delegations and the Commission in the continuation of negotiations on this dossier. The Presidency also took note of the broad support from delegations for the intention to conclude negotiations on the CAP reform as soon as possible.

• <u>The Council</u> took note of the information provided by the Presidency on the ongoing inter-institutional negotiations on the Horizontal Regulation on the basis of doc. 6919/21.

The Council exchanged views on the Presidency compromise suggestions for a number of issues related to conditionality, transparency and the protection of the EU financial interests and of the comments of delegations and of the Commission. <u>The Presidency</u> would take into account the comments from delegations and the Commission in the continuation of negotiations on this dossier.


