Subject: END OF WRITTEN PROCEDURE

Proposals for Council implementing decisions amending implementing decisions granting temporary support under Regulation (EU) 2020/672 to Belgium, Cyprus, Greece, Latvia, Lithuania and Malta to mitigate unemployment risks in the emergency following the COVID-19 outbreak
– Adoption

Delegations are informed that the written procedure, opened by CM 2792/21 of 21 April 2021, was completed on Friday, 23 April 2021, and that all delegations voted in favour of the adoption of:
