Appointment of Ms Ana OLIM, member for Portugal, in place of Ms Sandra RIBEIRO, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Sandra RIBEIRO, as member of the Management Board of the above Centre in the government representatives category (for Portugal).
2. Under Article 4 of Regulation (EU) 2019/128 of the European Parliament and of the Council establishing the European Centre for the Development of Vocational Training (Cedefop), and repealing Council Regulation (EEC) No 337/75, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/128 of the European Parliament and of the Council establishing the European Centre for the Development of Vocational Training (Cedefop), and repealing Council Regulation (EC) No 337/75¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019² the Council appointed the members and alternate members of the Management Board of the European Centre for the Development of Vocational Training for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as member in the government representatives category has fallen vacant as a result of the resignation of Ms Sandra RIBEIRO.
- (3) The government of Portugal has nominated a candidate for the vacant seat,
