Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>2</sup>, and in particular Articles 23 and 24 thereof.

#### Whereas:

- (1) In its Decisions of 21 September 2020<sup>3</sup> and 11 December 2020<sup>4,5</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2022.
- (2) A seat as member in the trade unions' representatives category has fallen vacant as a result of the resignation of Mr Adam ROGALEWSKI.
