1. The General Secretariat of the Council has been informed of the resignation of Mr Mario CARDONA, as alternate member of the Management Board of the above Centre in the government representatives category (for Malta).
2. Under Article 4 of Regulation (EU) 2019/128 of the European Parliament and of the Council establishing the European Centre for the Development of Vocational Training (Cedefop), and repealing Council Regulation (EEC) No 337/75, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/128 of the European Parliament and of the Council establishing the European Centre for the Development of Vocational Training (Cedefop), and repealing Council Regulation (EC) No 337/75¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019², 8 July 2019³, 16 September 2019⁴ and 8 November 2019⁵, the Council appointed the members and alternate members of the Management Board of the European Centre for the Development of Vocational Training for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Mario CARDONA.
- (3) The government of Malta has nominated a candidate for the vacant seat,
