## ANNEX

In Annex XVII to Regulation (EC) No 1907/2006, the following entry is added:

<p>'XX.</p> <p><i>N,N</i>-dimethylformamide</p> <p>CAS No 68-12-2</p> <p>EC. No 200-679-5</p>	<p>1. Shall not be placed on the market as a substance on its own, as a constituent of other substances, or in mixtures in a concentration equal to or greater than 0,3 % after [<i>OP, please insert the date: 24 months after the entry into force of this amending Regulation</i>] unless manufacturers, importers and downstream users have included in the relevant chemical safety reports and safety data sheets, Derived No-Effect Levels (DNELs) relating to exposure of workers of 6 mg/m<sup>3</sup> for exposure by inhalation and 1,1 mg/kg/day for dermal exposure.</p> <p>2. Shall not be manufactured, or used, as a substance on its own, as a constituent of other substances, or in mixtures in a concentration equal to or greater than 0,3 % after [<i>OP, please insert the date: 24 months after the entry into force of this amending Regulation</i>] unless manufacturers and downstream users take the appropriate risk management measures and provide the appropriate operational conditions to ensure that exposure of workers is below the DNELs specified in paragraph 1.</p> <p>3. By way of derogation from paragraphs 1 and 2, the obligations laid down therein shall apply from [<i>OP, please insert the date: 36 months after the entry into force of this amending Regulation</i>] in relation to placing on the market for use, or use, as a solvent in direct or transfer polyurethane coating processes of textiles and paper material or the production of polyurethane membranes, and from [<i>OP, please insert the date: 48 months after the entry into force of this amending Regulation</i>] in relation to placing on the market for use, or use, as a solvent in the dry and wet spinning processes of synthetic fibres.'</p>
