**Regulation on CAP Strategic Plans**

The SCA took note of the information provided by the Presidency on the outcome of the tenth trilogue on the CAP Strategic Plans Regulation held on 11 May, and of the comments from delegations and the Commission.

In preparation for the "Agriculture and Fisheries" Council on 26 and 27 May, delegations shared with the Presidency their views on specific elements of the proposal and in particular on the social dimension of the CAP. The Presidency would take into account the outcome of this meeting for the continuation of the negotiations with the European Parliament at the "super-trilogue" on 25 and 26 May, and would come back to Ministers for further guidance if need be.

### **Regulation on common market organisation (CMO) of agricultural products**

The SCA took note of the information provided by the Presidency on the outcome of the seventh trilogue on the CMO Regulation held on 12 May. The Presidency took note of the comments from delegations and the Commission and would take them into account in the ongoing negotiations.
