Subject:	Draft REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL establishing the European Social Fund Plus (ESF+) and repealing Regulation (EU) No 1296/2013 (first reading) - Adoption of the Council's position at first reading and of the statement of the Council's reasons

1. On 30 May 2018 the Commission sent its proposal¹ based on Articles 46, 149, 153(3), 164, 168(5), 175(3), and 349 TFEU and on 28 May 2020 the amended proposal² based on Articles 46, 149, 153(2), 164, 175(3), and 349 TFEU, to the Council.
2. The European Economic and Social Committee delivered its opinions on 17 October 2018³ and 18 September 2020⁴.

3. The Committee of the Regions delivered its opinions on 5 December 2018⁵ and 14 October 2020⁶.
4. The European Parliament adopted its position at first reading on 4 April 2019⁷.
5. The Permanent Representatives Committee confirmed on 3 March 2021 the provisional agreement reached by the co-legislators.
6. Subsequently, on 4 March 2021 the European Parliament Committee on Employment and Social Affairs (EMPL) confirmed the provisional agreement and its chair sent a letter on the same day to the chair of Coreper declaring that the European Parliament should, at its second reading, approve the Council's position at first reading (following a legal-linguistic review) without amendments.
7. The Permanent Representatives Committee is therefore asked to suggest that the Council:
 - adopt its position at first reading, as set out in document 6980/21, and the statement of reasons, as set out in document 6980/21 ADD 1, as an 'A' item at a forthcoming meeting, with Hungary abstaining;
 - decide that the statements in Addendum 1 to this note be entered in the minutes of that meeting.
8. At the same time, the Permanent Representatives Committee is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision (EU) 2021/454⁸, that the Council use the written procedure for the adoption of the abovementioned Regulation if, due to the circumstances related to COVID-19, no Council meeting takes place before 29 May 2021.
