Subject: Draft REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the European Regional Development Fund and on the Cohesion Fund **(first reading)**
- Adoption of the Council's position at first reading and of the statement of the Council's reasons

1. On 29 May 2018 the Commission sent its proposal¹ and on 28 May 2020 its amended proposal², based on Articles 177(2), 178 and 349 TFEU, to the Council.
2. The European Economic and Social Committee delivered its opinions on 17 October 2018³ and on 18 September 2020⁴.
3. The Committee of the Regions delivered its opinions on 5 December 2018⁵ and on 14 October 2020⁶.

4. The European Parliament adopted its position at first reading on 27 March 2019⁷.
5. The Permanent Representatives Committee confirmed on 3 March 2021 the provisional agreement reached by the co-legislators.
6. On 16 March 2021, the European Parliament's Committee on Regional Development (REGI) confirmed the provisional agreement, and its chair subsequently sent a letter to the chair of Coreper declaring that the European Parliament should, at its second reading, approve the Council's position at first reading (following a legal-linguistic review) without amendments.
7. The Permanent Representatives Committee is therefore asked to suggest that the Council:
 - adopt its position at first reading, as set out in document 6168/21, and the statement of reasons, as set out in document 6168/21 ADD 1, as an 'A' item at a forthcoming meeting;
 - decide that the statements in Addendum 1 to this note be entered in the minutes of that meeting.
8. At the same time, the Permanent Representatives Committee is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision (EU) 2021/454⁸, that the Council use the written procedure for the adoption of the abovementioned Regulation if, due to the circumstances related to COVID-19, no Council meeting takes place before 29 May 2021.
