**STATEMENT BY SLOVAKIA in connection with the last AGRIFISH Council (26.-27.5.)**

Slovakia finds it unacceptable that the Ministers did not have full interpretation during such an important meeting as the Council of Ministers, although it had been confirmed that it would be provided. We strongly believe that it was an unfortunate decision and that, in the future, Ministers must always have the possibility of expressing the positions of their country in their mother tongue.

This situation was all the more serious because we were not notified in advance of the absence of interpretation and, therefore, we could not provide a replacement solution for the meeting. We hope that this kind of situation will be avoided in the future.
