The SCA exchanged views on specific elements of the CAP reform on the basis of Presidency suggestions. The Presidency will take into account the outcome of the discussion for the continuation of the negotiations with the European Parliament at the super-trilogue on 24 and 25 June.

The Presidency also noted that the technical changes set out in document WK 8079/2021 REV 1 could be accepted as “A” points at the super-trilogue.

The Presidency informed the SCA about its intentions for the "Agriculture and Fisheries" Council on 28 and 29 June.

Information from the Presidency

The SCA took note of the information provided by the Presidency and of the reactions of delegations and the Commission.

b) Organisation of future work

The Presidency informed the SCA about the next steps ("Any other business" item at the next Council meeting) in the REAA (Regulation amending Regulation (EC) No 138/2004 as regards regional economic accounts for agriculture) and SAIO (Regulation on statistics on agricultural input and output and repealing Regulations (EC) No 1165/2008, (EC) No 543/2009, (EC) No 1185/2009 and Council Directive 96/16/EC) files.

The Presidency also informed the SCA about the next "Agriculture and Fisheries" Council meeting on 28-29 June 2021, and discussed the possibility of convening an extraordinary meeting of the Agricultural Attachés in the weekend preceeding that Council meeting. If confirmed, delegations would be informed in due course.

The incoming Slovenian Presidency informed the SCA about the next SCA meetings on 5 and 12 July and on the next "Agriculture and Fisheries" Council meeting on 19 July 2021.
