Subject:	Transfer of appropriations No DEC 13/2021 within Section III - Commission - of the general budget for 2021

1. On 21 June 2021, the Commission submitted to the Council proposal for transfer of appropriations No DEC 13/2021, in accordance with Article 31(1) of the Financial Regulation¹.

The purpose of this proposal is to transfer an amount of EUR 2.6 million in commitment (c/a) and payment appropriations (p/a) from Article 30 02 02 (*Differentiated appropriations*) to Article 08 05 01 (*Establishing a governance framework for fishing activities carried out by Union fishing vessels in third-country waters*), as recorded in document 10010/21.

2. The aim of this transfer is to cover the 2021 financial contributions as outlined in the protocols implementing the Sustainable Fisheries Partnerships Agreements between the EU and Gabon.
 3. The Budget Committee examined this proposal for a transfer at its meeting on 1 July 2021.
 4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 10010/21, and
 - the draft letter in the ANNEX to that effect.
