I. <u>INTRODUCTION</u>

- On 29 May 2018 the Commission adopted the proposal on specific provisions for the European territorial cooperation goal (Interreg) supported by the European Regional Development Fund and external instruments¹.
- 2. The Interreg Regulation was presented to the Structural Measures Working Party (SMWP) in June 2018 during the Bulgarian Presidency.

- 3. Detailed examination of the Interreg Regulation by the SMWP started under the Austrian Presidency. Under its term, the General Affairs Council dedicated to Cohesion Policy on 30 November 2018 gave specific guidance on the architecture of the Interreg Regulation.
- 4. The <u>Romanian Presidency</u> pursued the work on the file with a detailed examination of the full Interreg Regulation and its Annex. On 29 May 2019 the <u>Permanent</u>

 <u>Representatives Committee</u> agreed on a partial mandate for negotiations on the Interreg Regulation (ST 10285/19).
- 5. The <u>Economic and Social Committee</u> and the <u>Committee of the Regions</u> have been consulted on the Interreg Regulation and have adopted their opinions on 19 September and 5 December 2018, respectively.
- 6. The <u>European Parliament</u> voted its first reading position on the Interreg Regulation on 26 March 2019.

II. STATE OF PLAY

Framework (MFF), all provisions with budgetary implications or of a horizontal nature have been set aside (in square brackets) for the time being - and thus excluded from the negotiations - pending further progress on the MFF. These provisions under the Interreg Regulation are: Article 9 (ERDF resources for Interreg), Article 13 (co-financing rates), paragraph 2 of Article 49 (pre-financing), all references to the PEACE PLUS programme and to contributions to the EU budget by external assigned revenue. Chapter VIII on the participation of third countries or partner countries or OCTs in Interreg programmes under shared management is also in square brackets given its sensitivity, and therefore dependent on the outcome of the horizontal negotiations on the MFF; however those amendments made to Chapter VIII by the SMWP during its work on the file have been already included in the text.

- 8. Inter-institutional negotiations on this file started under <u>Finland's Presidency</u>. 6 technical meetings (23 October; 5, 12, 19 and 26 November; and 3 December) and 2 trilogues (20 November and 10 December) with the REGI Committee took place, with the following Articles being examined:
 - Articles 1-8 (rows 2-75): Subject matter and scope, definitions and components,
 geographical coverage;
 - Articles 10-12 (rows 93 123): Cross-fund provisions, list of programme resources, discontinuation;
 - Articles 14-15 (rows 126 159): Interreg-specific objectives, thematic concentration;
 - Articles 16-21 (rows 160 246): Preparation approval and amendment of programmes, territorial development;
 - Articles 22-26 (rows 247-321): Operations, small project funds, technical assistance;
 - Articles 36-43 (rows 412-518): Eligibility;
 - Articles 44-48 (rows 519-572): Programme authorities, management, control and audit.
- 9. Substantial progress has been made during the inter-institutional negotiations on the Interreg Regulation, with a provisional common understanding between the European Parliament and the <u>Presidency</u> being reached in most of the provisions being examined. Following the trilogues of 20 November and 10 December and the examination of the four-column table by the Structural Measures Working Party on 6 and 11 December, the Presidency is of the view that, based on the principle that "nothing is agreed until everything is agreed", a balanced compromise text has emerged from the inter-institutional negotiations on a substantial part of the Regulation. The Presidency regards the package as the best possible compromise, taking into account the European Parliament's ambitions for these blocks.
