The expression of the Union position in a body set up by an agreement is an act of external representation of the Union which, in accordance with Article 17(1) TEU, is the institutional prerogative of the Commission.

The Commission reserves all its rights in this regard."

#### Joint statement by France and Italy

"Le projet de décision du Conseil sur la position à prendre au nom de l'Union européenne dans le cadre du Conseil des membres du Conseil oléicole international (COI) sur les normes commerciales concernant les huiles d'olive et grignons d'olives, qui se réunira les 28-30 juin prochains, prévoit que l'Union européenne apporte son soutien à la décision d'adoption du « paquet de normes commerciales », y compris la proposition relative à l'abaissement de la limite inférieure du niveau d'acide palmitique de 7,5% à 7%.

La France et l'Italie appellent à la vigilance quant à la mise en œuvre de cette proposition qui, si elle était effectivement adoptée par le COI, pourrait compliquer la détection des fraudes et porter ainsi atteinte à la protection du consommateur et à la défense de l'authenticité des huiles d'olive, pour les raisons notamment exposées dans les commentaires circulés par la France le 26 mai 2021 (cf. document WK 6025/2021 REV 1 ADD 2).

En effet, bien que classé dans les paramètres d'analyse « non critiques », et bien qu'il ne soit pas le seul moyen analytique pour détecter la fraude, l'indice d'acide palmitique est un moyen rapide, facile et accessible de n'importe quel laboratoire pour déterminer si une huile d'olive a été altérée ou non par d'autres huiles de moindre qualité. A l'issue de recherches techniques récentes, non disponibles au moment des échanges au niveau des groupes d'experts, la France a pu évaluer que l'abaissement de l'indice inférieur d'acide palmitique de 0,5% permettrait d'altérer les huiles d'olive (d'indice palmitique généralement élevé, de l'ordre de plus de 7,5%) en les mélangeant avec d'autres huiles de moindre qualité (à l'indice palmitique inférieur comme le colza ou le tournesol) dans une proportion non négligeable, à hauteur de 14%, sans possibilité de détecter rapidement la fraude.

La France et l'Italie souhaitent, dans ce contexte, que la mise en œuvre éventuelle d'une telle mesure, d'une part fasse l'objet d'analyses techniques complémentaires approfondies, en complément de celles présentées lors de la réunion du COI d'octobre 2020 (analyse en nombre sur plusieurs années et incidence sur les autres critères d'analyse), et d'autre part qu'elle soit assortie d'un dispositif de suivi et de monitoring précis de son impact, s'agissant notamment de l'authenticité des produits mis sur le marché.

La France et l'Italie souhaitent, enfin, que cette mesure fasse l'objet d'un bilan d'étape lors de la tenue d'un prochain COI./."

**Statement by Bulgaria, the Czech Republic, France, Germany, Hungary, Italy, Poland and Slovakia**

"We support the creation of a protection system of geographical indications (hereafter 'GIs') for non-agricultural products based on a *sui generis* intellectual property right at EU level. We underline that by its accession to the Geneva Act of the Lisbon Agreement on Appellations of Origin and Geographical Indications (hereafter 'Geneva Act'), the EU undertook the obligation of establishing such a protection system. The commitment to protect GIs, regardless of whether agricultural or non-agricultural products are concerned, undoubtedly results from Article 9 of the Geneva Act. Thus, the question of whether a system for non-agricultural products is to be established, has already been answered and the focus should now be placed on the question of "how".

Despite the fact that the EU is a member of the Lisbon system for the international registration of appellations of origin and GIs, it is currently not possible for EU producers to protect their non-agricultural GIs under the Geneva Act. Additionally, the continuous fragmentation of legal protection of non-agricultural GIs within the EU may have implications for the functioning of the European Single Market, for European and regional competitiveness and for EU trade relations with third countries.

We are convinced that the introduction of an EU-wide *sui generis* GI protection for non-agricultural products would have an overall positive effect on trade, employment, SMEs and rural development. Moreover, it can powerfully advance commercial and economic interests while fostering local values such as culture and tradition. It would be a boost for tourism in the producers' regions, thus also playing an important role in the recovery after the COVID-19 pandemic. Such a harmonized system would increase the uniqueness and attractiveness of the protected products by guaranteeing their quality and effective protection against losses caused by counterfeiting and imitations, including within EU trade agreements.

We recall that the European Parliament is also of the view<sup>1</sup> that it would be highly recommended for the EU to adopt legislation on non-agricultural GIs in order to fully exploit the positive economic effects of protecting the distinctiveness and quality of such products.

For these reasons, we call on the Commission to submit a legislative proposal to that effect in line with the timeline set out in the Commission's Intellectual Property Action Plan."

Statement by Spain, Lithuania, Estonia, the Czech Republic, Denmark, Sweden, Italy, Poland, Bulgaria and Germany

"The Council Conclusions on Better Regulation of 27 May and the Commission Communication on Better Regulation of 29 April both outline the increased importance of Better Regulation and evidenced based policy making in the context of the unprecedented challenges the EU is facing and the ambitious policy agenda foreseen in the coming years.

The Annual Report on impact assessment within the Council is an important tool to analyse the actual state of play of Better Regulation and to look for concrete improvements in the future. As stated in the report itself, its main tasks are to present scenarios and recommendations aimed inter alia at ensuring proper follow-up and implementation of the provisions of the Inter-Institutional Agreement (IIA) on Better Law-Making of 13 April 2016.

With respect to this main task, especially two areas would benefit from increased analysis as well as more reflection on improvements in the Annual Report:

- (1) The IIA states that for impact assessments on delegated acts and implementing measures the same criteria apply as for legislative proposals like regulations or directives. The Annual Report should in the future analyse also the implementation of this provision of the IIA.
- (2) The Council has committed itself in the IIA to carry out impact assessments in relation to its substantial amendments when it considers this to be appropriate and necessary for the legislative process. So far, the Council has not carried out any impact assessment. This fact has been underlined on several occasions by the Commission (for instance in the recent Commission Communication on Better Regulation) and by many stakeholders. From that perspective, it would be beneficial if the Annual Report presented scenarios and recommendations for improving the implementation of this provision of the IIA in the future.

Being a report on the topic of Better Regulation, the Annual Report needs especially to pay attention to a solid evidence base and a clear representation of the state of play based on the criteria agreed in the IIA. In this regard, the overview tables presented in the Annex would benefit in the future from an alignment to the criteria set out in the IIA and of consistent as well as complete information for instance on which proposals are part of the Commission Work Programme and the Joint Declaration. Also, additional calculations on missing impact assessments that are not based on the criteria set out in the IIA (like in para 36 of the 2021 Annual Report) should be handled with great care.

In order to increase the future quality and comprehensiveness of the Annual Report, improvements of the drafting process with regard to timing and sequencing would be important. It would be very beneficial to have an in-depth discussion of the draft report in the Working Party on Competitiveness and Growth (Better Regulation) and a finalisation of the report in the Mertens Group. For both steps sufficient time needs to be allocated."
