It also took note of the Commission's view that both acts fall under Union competence and of its recommended position for each act, as well as of the Council Legal Service opinion on the competence issue as set out in document 10328/21.

The SCA also noted the reservations entered by some delegations on the competence issue and their request for this issue to be discussed further, as well as the comments made by some delegations in relation to the content of the two acts. On this basis it noted the absence of a common position on each act and its consequences.
