 On 16 July 2020, the <u>Commission</u> submitted to the Council the proposal for a Council Decision amending Decision 2003/76/EC establishing the measures necessary for the implementation of the Protocol, annexed to the Treaty establishing the European Community, on the financial consequences of the expiry of the ECSC Treaty and on the Research Fund for Coal and Steel¹.

- 2. The Research Fund for Coal and Steel (RFCS) is an EU research programme, funded outside the Multiannual Financial Framework by the revenue of the assets of the European Coal and Steel Community (ECSC) in liquidation allocated to this fund according to Protocol 37. In accordance with this Protocol, the RFCS finances exclusively research projects in the coal and steel sectors.
- 3. The aim of the proposed Decision is to allow selling a share of the assets of the European Coal and Steel Community (ECSC) in liquidation for the period 2021-2027 in order to provide an annual Research Fund for Coal and Steel (RFCS) allocation of EUR 111 million. This annual allocation will continue to support collaborative research in the coal and steel sectors and will enable the funding of breakthrough technologies leading to near zero-carbon steel-making projects, as well as research projects for the just transition of coal mines and related infrastructure.
- Following the work since September 2020 within the <u>Research Working Party</u>, resulting to some limited changes to the initial proposal, the <u>Council</u> (Competitiveness) at its meeting of 27-28 May 2021, adopted a General Approach on the text.
- 5. On 28 June 2021, the <u>Council</u> requested the consent of the European Parliament on the draft Council Decision, in accordance with the first paragraph of Article 2 of Protocol No 37 on the financial consequences of the expiry of the ECSC Treaty and on the Research Fund for Coal and Steel.
- 6. The European Parliament gave its consent on 7 July 2021.
- 7. The <u>Permanent Representatives Committee</u> is therefore invited to recommend to the <u>Council</u>, as an "A" item in one of its next sessions:
 - to adopt the draft Council Decision amending Decision 2003/76/EC establishing the measures necessary for the implementation of the Protocol, annexed to the Treaty establishing the European Community, on the financial consequences of the expiry of the ECSC Treaty and on the Research Fund for Coal and Steel, as finalised by the lawyerlinguists and set out in doc. 9399/1/21;

 to request publication of the Decision in the Official Journal of the European Union for information.
