Statements to the legislative "B" items set out in doc. 9384/21**Ad "B" item 3:** **Regulation on Assignments of Claims**
*General approach***STATEMENT BY BELGIUM**

“Belgium generally supports the objectives pursued by the proposed Regulation and accepts the text presented for a general approach. Belgium however regrets the lack of clarity of the proposal, which may lead to difficulties of application. Belgium also regrets the solution adopted concerning the assignment of claims secured by a security right over immovable property or moveable property subject to registration in a public register. Belgium would have preferred an exclusion of priority conflicts over these secured claims, which would have been clearer and simpler to apply. We hope that these elements can be improved during the future interinstitutional negotiations with the European Parliament and that they will be subject of a particular attention during the review of the instrument provided for in Article 13.”

Ad "B" item 4: **Regulation on e-CODEX system and amending Regulation**
(EU) 2018/1726
*General approach***STATEMENT BY ESTONIA AND FRANCE**

“Estonia and France welcome the objective of the Commission proposal and the text of the general approach prepared by the Portuguese Presidency.

As to the location of e-CODEX, Estonian and French delegations propose e-Codex to be handled entirely in Tallinn, and that the eu-LISA Regulation (2018/1726) is amended as follows in the course of the next negotiation phases:

- In article 17 (3), the following shall be added: “The tasks relating to the development and operational management of the e-Codex system referred to in articles 1(4a) and 8b shall be carried out in Tallinn, Estonia, where the necessary equipment for these tasks is installed.”
- As a consequence, in order to avoid contradiction between the subparagraphs of article 17 (3), the reference to article 1 (4a) shall be added in article 1 (5) (changes with bold and strikethrough): “*The Agency may be made responsible for the preparation, development or operational management of large-scale IT systems in the area of freedom, security and justice other than those referred to in paragraphs 3, and 4 and 4a of this Article, including existing systems, only if so provided by relevant Union legal acts governing those systems, based on Articles 67 to 89 TFEU, taking into account, where appropriate, the developments in research referred to in Article 14 of this Regulation and the results of pilot projects and proofs of concept referred to in Article 15 of this Regulation.*”

STATEMENT BY BULGARIA

“The Republic of Bulgaria understands the reporting on common indicators in Annexes I and II of the European Social Fund Plus Regulation and in Annex III of the Just Transition Fund Regulation by using a category of “non-binary”, as not obligatory. The Republic of Bulgaria does not intend to gather and report relevant data, as such a category does not exist in its national legislation.”

STATEMENT BY HUNGARY

“The procedure towards the adoption of the Cohesion Policy regulations has reached another important step. Hungary sees it necessary to reiterate its earlier statement regarding the representation and interpretation of gender in these regulations.

Equality between women and men is enshrined in the treaties of the European Union as a fundamental right. Hungary ensures equality between women and men within the framework of its national legal system in accordance with internationally binding human rights instruments and within the framework of fundamental values and principles of the European Union.

For these reasons Hungary interprets the concept of “gender“ as reference to sex, in line with Article 8, 10, 19 and 157 of the Treaty on the Functioning of the European Union and Article 21 and 23 of the Charter of Fundamental Rights of the European Union.

Furthermore Hungary is convinced that the content of gender is not appropriate to be defined in these legislative documents.

In line with these and its national legislation, Hungary interprets the concept of ‘gender’ as reference to ‘sex’ and the concept of ‘gender equality’ as reference to the ‘equality between men and women’ in the Regulations. As regards the breakdown of data, Hungary believes that footnote 2 in Annex III of JTF Regulation (and also the first line of Annex I and Annex II respectively of the ESF+ Regulation) should be applied and refer to the term “gender” and the parenthesis as a whole and not only one of the subcategories listed there.

Bearing in mind the fact that determining the content of the term “gender” falls under the exclusive competence of the Member States, the relevant recitals, articles, annexes and footnotes should be understood as referring to the term gender interpreted in accordance with national legislation.”

STATEMENT BY POLAND

“Equality between women and men is enshrined in the treaties of the European Union as a fundamental right. Poland ensures equality between women and men within the framework of the Polish national legal system in accordance with internationally binding human rights instruments and within the framework of fundamental values and principles of the European Union. For these reasons, in wordings referring to gender Poland will interpret it as a equality between women and men, according to Article 8 TFEU.”
