EXPLANATORY MEMORANDUM

1. CONTEXT OF THE DELEGATED ACT

Article 4(1) of Regulation (EU) 2019/1700 of the European Parliament and Council establishing a common framework for European statistics relating to persons and households, based on data at individual level collected from samples, empowers the Commission to adopt delegated acts to supplement that Regulation by establishing or adapting a system of multiannual rolling planning. This planning system will:

- (a) be adopted for a period of eight years;
- (b) cover the collection of data under the Regulation;
- (c) ensure that samples are collected at regular intervals, according to periodicities specified in Annex IV;
- (d) specify the period during which data are to be collected:
 - (i) the detailed topics attached to the domains listed in Annex I;
 - (ii) ad-hoc subjects requested by users for the labour force and income and living conditions domains, as provided for in Annex IV.

To implement Regulation (EU) 2019/1700 in 2021, this delegated Commission Regulation defines the first system of multiannual rolling planning to be used for the eight years from 2021.

2. CONSULTATIONS PRIOR TO THE ADOPTION OF THE ACT

In preparing this delegated act, the Commission has conducted appropriate consultations. It has consulted national experts invited to expert meetings to discuss the draft act. These consultations took place at the meetings of the European Directors of Social Statistics held on 23-24 May 2019 and 27-28 June 2019.

The Commission has also consulted the expert group representing the National Statistical Institutes of the European Statistical System.

Finally, it has kept the European Parliament and the Council informed of the consultations.

3. LEGAL COMPONENTS OF THE DELEGATED ACT

The purpose of this delegated act on the system of multiannual rolling planning is to specify the periods during which data are to be collected on the detailed topics attached to domains listed in Annex I to Regulation (EU) 2019/1700 and ad-hoc subjects requested by users for the labour force domain and the income and living conditions domain, as provided for in Annex IV to Regulation (EU) 2019/1700. The act establishes the frequency with which data collections are to be held (periodicity). First, it establishes the period during which data are to be collected for data collections with one periodicity as defined in Annex IV of Regulation (EU) 2019/1700. Second, it groups the detailed topics by periodicity and sets the data collection period for data collections with several periodicities.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2019/1700 of the European Parliament and of the Council of 10 October 2019 establishing a common framework for European statistics relating to persons and households, based on data at individual level collected from samples, amending Regulations (EC) No 808/2004, (EC) No 452/2008 and (EC) No 1338/2008 of the European Parliament and of the Council, and repealing Regulation (EC) No 177/2003 of the European Parliament and of the Council and Council Regulation (EC) No 577/98¹, and in particular Article 4 (1) thereof,

Whereas:

- A system of multiannual rolling planning is to be adopted for an eight-year period in order to regulate the collection of data covered by Annex IV to Regulation (EU) 2019/1700, in particular comply with the periodicity specified by that Annex, and specify the period during which data are to be collected.
- (2) The Commission should ensure that this act complies with the principle of proportionality and does not impose a significant burden or cost on Member States or respondents.
- (3) The Commission has carried out appropriate consultations of national experts in preparation of this delegated Regulation.

HAS ADOPTED THIS REGULATION:

Article 1

Subject matter

This Regulation establishes the multiannual rolling planning for the collection of data under Regulation (EU) 2019/1700 from 2021 to 2028.

Article 2

Data collection periods for domains and for associated detailed topics

- 1. For domains with only one periodicity, as listed in points 3 to 7 of Annex IV to Regulation (EU) 2019/1700, the data collection period shall be as set out in part A of Annex I to this Regulation.
- 2. For domains with several periodicities, as listed in points 1 and 2 of Annex IV to Regulation (EU) 2019/1700, the data collection period shall be as set out in part B of Annex I to this Regulation. For that purpose, the detailed topics attached to these domains shall be grouped, as set out in Annex II to this Regulation.

Article 3

Data collection periods for ad-hoc subjects requested by users

The data collection period for ad-hoc subjects requested by users shall be as set out in part B of Annex I.

Article 4

Entry into force

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States. Done at Brussels, 16.12.2019
