- <u>The General Secretariat of the Council</u> has been informed of the resignation of Ms Maria Luísa TORRES ECKENROTH GUIMARÃES, as member of the Management Board of the above Agency in the governments' representatives category (for Portugal).
- Under Article 4 of Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019², 6 June 2019^{3,4} and 8 July 2019⁵, the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as member in the governments' representatives category has fallen vacant as a result of the resignation of Ms Maria Luísa TORRES ECKENROTH GUIMARÃES.
- (3) The Government of Portugal has nominated a candidate for the vacant seat,
