

## 1. Cumulative data for the current programming period (1 January 2014 – 31 December 2020)

Every year, more data are available to identify trends in applications and to present an overview of the direction of the fund's activities. The data in the following charts (charts 1 to 8) and Table 1 relate to 54 applications<sup>1</sup> submitted by Member States between 2014 and 2020 under Regulation (EU) No 1309/2013 of the European Parliament and of the Council of 17 December 2013 on the European Globalisation Adjustment Fund (2014-2020) and repealing Regulation (EC) No 1927/2006. A total of EUR 173 400 703 has been requested from the EGF for measures to help 58 267 targeted beneficiaries<sup>2</sup>.

*Chart 1: Number of applications submitted between 2014 and 2020*




Between 2014 and 2020, the Commission received 23 crisis-related applications and 31 trade-related applications. The total number of applications received each year varies, with an average of around 8 applications per year. Table 2, shows that Greece and Finland have submitted the highest number of applications (8 each) in the current programming period, followed by Belgium (7) and Spain (6).

**Chart 2: Number of applications by sector\* (NACE Rev. 2) between 2014 and 2020**





From 2014 to 2020, the Commission received 54 applications related to a broad range of sectors (40). The highest number of applications was submitted for the retail trade sector (6), followed by the motor vehicles, trailers and semi-trailers sector (5) and the air transport sector (5).

Table 3 sets out the details of the applications submitted by sector.

### Total number of targeted workers: 54 168

Between 2014 and 2020, the Commission received EGF applications submitted by 12 Member States for 54 168 targeted workers in 40<sup>4</sup> different sectors. The highest number of targeted workers was in the motor vehicles, trailers and semi-trailers sector (10 299), followed by the retail trade sector (4 943) and the land transport and transport via pipelines sector (4 676).


### Total number of targeted young people not in education, employment or training (NEETs): 4 099

There were 12 applications submitted by five Member States over the 2014-2020 period that targeted 4 099 NEETs. Member States that applied for NEETs support were: Greece (4 applications – 2 098 NEETs), Belgium (3 applications – 700 NEETs), Ireland (3 applications – 446 NEETs), Portugal (1 application – 730 NEETs), and Spain (1 application – 125 NEETs).

*Chart 4: Number of targeted beneficiaries per Member State between 2014 and 2020*




**Total number of targeted beneficiaries:** 58 267

**Average number of targeted beneficiaries per Member State:** 4 856

Between 2014 and 2020, the applications submitted from the 12 Member States targeted 58 267 beneficiaries (workers and NEETs). Belgium requested support for the highest number of beneficiaries (11 393), followed by France (9 620) and Finland (7 527).

The number of targeted beneficiaries includes workers and NEETs. Table 2 sets out the details of the applications per year and Member State.



**Total number of assisted\* workers:** **34 940**

Between 2014 and 2020, 54 applications were submitted requesting EGF co-financing for a total of 54 168 targeted workers (including 36 521 men and 17 647 women) and representing 72% of the 75 021 dismissed workers in total.

\*Member States marked with an asterisk still have EGF cases under implementation; the total number of assisted workers is therefore not yet final.



Between 2014 and 2020, Belgium requested support for the highest number of targeted workers (10 693, representing 89% of dismissed workers), followed by France (9 620, representing 71% of dismissed workers) and Finland (7 527, representing 81% of dismissed workers).

**Chart 7: EGF amounts requested (in EUR) per Member State between 2014 and 2020**





Between 2014 and 2020, 12 Member States requested a total amount of EUR 173 400 703 from the EGF. Greece requested the highest amount (EUR 40 349 250, 8 applications), followed by France (EUR 34 716 088, 5 applications) and Finland (EUR 21 192 607, 8 applications).

Table 2 sets out the details of the applications per year and per Member State.

**Average EGF amount requested per beneficiary:** EUR 2 976

On average, each of the 12 Member States applying for EGF support between 2014 and 2020 requested EUR 2 976 per targeted beneficiary. The highest average amount per beneficiary was requested by Greece (EUR 5 429), followed by Ireland (EUR 4 707) and France (EUR 3 609).





*Chart 10: Number of targeted workers per Member State between 2007 and 2020*



**Chart 11: EGF amount requested (in EUR) per Member State between 2007 and 2020**





Between 2007 and 2020, the Commission received 166 EGF applications from a broad range of sectors (49). The highest number of applications was received for the manufacture of motor vehicles, trailers and semi-trailers sector (23), followed by the manufacture of computer, electronic and optical products sector (17) and the manufacture of machinery and equipment sector (15).

Four sectors (77, 91, 92 and 93) are not included in the chart because the number of workers dismissed from these sectors was unknown at the application stage<sup>6</sup>.

### Total number of targeted beneficiaries in 49 sectors: 163 297

Between 2007 and 2020, the Commission received EGF applications submitted by 20 Member States for 163 297 workers and NEETs made redundant. The highest number of workers was targeted in the manufacture of motor vehicles, trailers and semi-trailers sector (33 202), followed by the manufacture of computer, electronic and optical products sector (21 263), and the manufacture of machinery and equipment sector (11 657).
