The Commission requests the mobilisation of the Solidarity and Emergency Aid Reserve (SEAR) based on Article 9(1)(b) of the Multiannual Financial Framework Regulation. The request is justified by the unprecedented and exceptional influx of third-country nationals facilitated by the current regime of Belarus that put under pressure the reception and asylum system of Member States bordering Belarus, in particular Lithuania.

The amount requested is EUR 21 763 125 in commitment appropriations and it will be used to top up the Asylum, Migration and Integration Fund (AMIF) under the Budget 2021, i.e. the emergency assistance component of the Thematic Facility.

In addition, in view of the current migratory situation at the border between Belarus and Lithuania the Commission requests the reinforcement of the Border Management and Visa Instrument with an amount of EUR 34 074 162,50 in commitment appropriations. The amount will be made available by appropriations returned by the four Home Affairs agencies, i.e Frontex, eu-LISA, Europol and Cepol.

d) Detailed grounds for the decrease

Frontex has identified a surplus of EUR 14,5 million in commitment appropriations, mainly due to the constraints posed by the COVID-19 pandemic, which prompted the Agency to downsize its activities in the area of on boarding of Standing Corps. The lower numbers of recruits than initially forecast resulted in savings in salaries, allowances and other staff related expenditure. In addition, the budgetary needs for administrative expenditure are impacted by different circumstances with identified savings particularly in rental costs.

According to article 9 of the Multiannual Financial Framework Regulation, the Solidarity and Emergency Aid Reserve (SEAR) is intended to allow for

- (a) assistance to respond to emergency situations resulting from major disasters that are covered by the European Union Solidarity Fund, the objectives and scope of which are set out in Council Regulation (EC) No 2012/2002; and
- (b) rapid responses to specific emergency needs within the Union or in third countries following events which could not be foreseen when the budget was established, in particular for emergency responses and support operations following natural disasters not covered by point (a), man-made disasters, humanitarian crises in cases of large-scale public health, veterinary or phytosanitary threats, as well as in situations of particular pressure at the Union's external borders resulting from migratory flows, where circumstances so require.

d) Detailed grounds for the increase

Lithuania is experiencing an exceptional and unexpected situation, which is considered a hybrid threat: The number of irregular arrivals through the border with Belarus increased 55 times compared to 2020 and 112 times compared to 2019 up until 22 August. Lithuania currently has one of the highest ratio in the EU between population and irregular arrivals. The number of irregular arrivals was 37 in 2019, 74 in 2020 and 4 137 in 2021 (22 August data). There has been a corresponding increase in the asylum applications: on average, over the last years, Lithuania received about 400-500 asylum applications a year. By mid-August 2021 there were already 1 818 asylum applications being processed for this year alone, with more than 60% being made between weeks 28 and 32.

In view of this situation, Lithuanian authorities submitted in August an application for emergency assistance under AMIF (EUR 36,7 million EU contribution) to cover the basic needs related to the reception and asylum of up to 8 000 asylum seekers. The request covers the period July-December 2021. Lithuania has appealed to the Union Civil Protection Mechanism (UCPM). This will allow Lithuania to deal efficiently with these arrivals, including vulnerable groups, supporting its reception capacity, which is nearly exhausted, and providing for temporary accommodations that are winter proof, such as containers (not obtained under the UCPM).

The Commission awarded to Lithuania the requested amount as emergency assistance under the available AMIF 2021 envelope for emergency assistance (EUR 80 million) at the end of August. Under the same envelope, EUR 14 million have already been awarded to Spain to address the urgent migratory situation in Ceuta. Therefore, EUR 29 million remain available for emergency assistance.

The situation on the ground at the borders with Belarus remains volatile. Flights carrying irregular migrants to the Lithuanian border have diminished due to temporary suspension (until mid-September) of flights from Iraq, but could soon increase and, as border management in Lithuania has been stepped up with the support of Frontex, pressure could shift to other EU borders with Belarus. In the week of 16 August, there were 115 detected illegal border crossings from Belarus to Poland and 704 more attempts were prevented. 24 irregular migrants were after apprehended after crossing border from Belarus to Latvia illegally. 81 attempts were prevented. 30 irregular migrants are stranded at the Belarussian border with Poland and 83 at the border with Latvia.

The current amount available for emergency assistance under the AMIF is insufficient to respond to such needs. Other sources of financing within that Fund are not available, as the 2021-2022 AMIF Thematic Facility will have to address the policy priorities of the New Pact on Migration and Asylum (including resettlement and relocation) and provide support to other Member States facing increased migratory pressure, such as Italy (already counting more than 30 000 irregular arrivals this year), Cyprus and Greece.

Against this background, the Commission requests the transfer of the remaining EUR 21,8 million commitment appropriations from the internal component of the Solidarity and Emergency Aid Reserve to AMIF. This amount will top up the financial envelope for emergency assistance under the Thematic Facility for 2021.

Actions to be financed with the additional budget encompass setup of temporary reception and accommodation capacities, provision of basic needs like food, hygiene, (winter) clothing, specific assistance to vulnerable groups including unaccompanied minors, support to national authorities in asylum processing (translation, interpretation, legal advice), security in the temporary shelters, safety of migrants in the face of local protests, information and site management, and medical assistance in light of threats posed by COVID-19.

The Commission does not request a transfer of payment appropriations.

d) Detailed grounds for the increase

The reinforcement of the Border Management and Visa instrument (BMVI) with EUR 34 million in commitment appropriations will cover the additional needs already identified for Lithuania in light of the unprecedented irregular arrivals of third-country nationals, facilitated by the current regime of Belarus. The indicatively estimated need of Lithuania is EUR 42 million. Lithuania needs support to secure and manage its borders with Belarus, in particular to upgrade its surveillance systems and deploy it throughout the full length of the border. In addition, the Commission needs to be able to react quickly if/when similar needs arise in other EU Member States neighbouring Belarus.
